

**Corporate Social Responsibility (CSR)**

**1. A brief outline of the Company's CSR policy, including overview of projects or programs proposed to be undertaken and a reference to the web-link to the CSR policy and projects or programs.**

The Company has actively supported various initiatives in the areas of health, education and environment over the years. With the introduction of Section 135 of the Act, the Company has constituted a Corporate Social Responsibility (CSR) Committee. A CSR Policy was also framed detailing Policy statement, Scope of CSR Activities, CSR funds, modalities of execution of each selected project, how to monitor the activities, and various other matters relating to CSR and the policy is available on the Company's website [www.uenindia.com](http://www.uenindia.com). The CSR Policy was aimed at providing more focus and direction to the various activities on CSR being undertaken by the Company including through the Charitable Trust, K.A. Mathew Foundation, a Charitable trust having an established track record of more than 28 years in undertaking charitable activities. The projects undertaken by the Company were in the areas of a) Restoration and beautification of city, town, village etc, b) Eradicating hunger, poverty and malnutrition, c) Scholarship/promotion for education, d) Healthcare, e) Public recreation etc. These projects are in accordance with Schedule VII of the Companies Act, 2013.

**2. The Composition of the CSR Committee**

The CSR Committee was constituted by the Board in its meeting held on 27-06-2014 to formulate a CSR policy, recommend the amount of expenditure to be incurred and to monitor the CSR activities of the Company. Presently Dr. D. Babu Paul, Chairman, Mr. B. Jyothikumar, and Ms. Pamela Anna Mathew are the members of the Committee.

**3. Average net profit of the Company for last three financial years**

The Average net profit of the company for last three financial years amounts to Rs.14,79,98,343/-

**4. Prescribed CSR Expenditure (two per cent of the amount as in item 3 above)**

Prescribed CSR Expenditure for the Company was estimated at Rs.29,59,967/- being 2% of the average net profit of the Company for last 3 financial years.

**5. Details of CSR spent during the financial year**

a) The company has spent Rs.30,04,060/- during the Financial Year 2016-17 against the CSR Project/activities identified and approved by the CSR Committee.

The Company spent a total amount of Rs.30,04,060/- during the Financial Year 2016-2017 as against Rs.29,59,967/-, the prescribed CSR Expenditure.
