

TERMS & CONDITIONS

Submission

Proposed project may be submitted by each team before the due date as explained in the brochure. No edits /changes will be permitted once it is submitted. An acknowledgement by email will be received by each team within 7 working days of submission. The teams short listed for the final round of competition will be asked to travel to Cochin and the cost of travel of the team (strength limited to 5) by train in two tier AC, from the participating Institute's location to OEN India Ltd, Cochin and back will be reimbursed by OEN. Local Lodging and Boarding will have to be arranged by the teams themselves.

Competition Disqualification

The screening committee will screen each submission and those not complying with the competition guidelines / not meeting the rules and regulations and received after the closing date will be eliminated. Only the teams of selected entries will be intimated.

Competition Cancellation / Withdrawal

If due to any unavoidable circumstances the Competition has to be withdrawn it will be intimated to each selected team one month in advance before the last date for submission of the detailed project report.

Competition Integrity

O/E/N undertakes to carefully protect the integrity of the competitions by providing a unique registration number to each of the submissions. The participants should necessarily eliminate from the drawings, illustrations, or narratives all marks, logos, symbols or sign that would identify its origin/source. Similarly, the jury panel list will not be disclosed before completing the evaluation of projects and declaration of results of the competition. However, it can be revealed on request after the results are declared, but only on the sole discretion of the organizers (O/E/N).

Winner Selection / Jury's Decision

Selection of the projects (initial screening) and selection of the winners by the jury members will be final.

Organization and Administration

Award and competitions are organized and administered by O/E/N with its academic partner MITS (Muthoot Institute of Technology and Science). O/E/N & MITS holds the rights to appoint the juries, agents or others and assign responsibilities to them for smooth conduct of the competitions.

Awards and Prizes

The details of winners of the awards and prizes shall be communicated to all participants selected for competition. If the winner chooses not to accept the prize, the next in the merit list will be chosen as winner.

Registration Fees and Associated Cost

There is no registration fee for competitions but all project costs incurred by the entrants for participating in this competition will have to be borne by them.

Ownership and Copyright

The ownership of copyright of the work of all projects submitted will be with the author in accordance with the Copyright and Patent Act 1988.

Publicity

By participating in the competition, the entrant acknowledges and accepts that all aspects of their project submitted like the narratives, captions, descriptions, images, illustrations, animations etc., may be used for campaign purposes by O/E/N. The winners of the competition should agree to participate on request in Public Relations activity post competition, like interviews etc.

Publication

OEN may be allowed to publish relevant portions of the project material without affecting the copy right of author, in OEN's website or any journal or any campaign material, subject to provisions of Data Protection act.

Privacy Policy

O/E/N is aware of your privacy and its importance. Any information collected on our site is used only for processing and administration of your competition entry according to the competition guidelines, rules and regulations and optimize your visit to our site from your personal experience.

Data Protection
